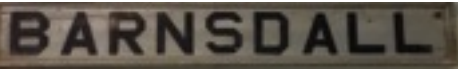

Coffeyville Refinery Engine

It has been reported that the CVR engine that has been setting in Coffeyville since February may have been vandalized. The batteries are missing and the lock removed from the cab. All of the engine compartment doors have been left open. Although there is concern on the condition of the engine, there has been no official report on any vandalism to the engine at this time. Rick Webb and Brad Snow have been notified and Brad is working on getting it moved. There are items that need to be repaired before the move can take place. The railroad is working on a cost for repair of the items. More news will be posted as we learn more.

Dave Parker and Larry Spahn recently took a whirlwind trip to Colorado to ride four of their scenic railroads. The first day took them to Canon City and the Royal Gorge train ride with tickets for the first class observation car. This was a great ride and it passes beneath the suspension bridge which is over nine hundred feet above the train. The next day found them aboard the Cinco Animas with first class accommodations on the Durango Silverton Scenic railroad. They rode the train to Silverton and took the bus back to Durango, the bus ride was also a neat trip. From Durango they traveled to Chama, New Mexico where they spent the night in the old Shamrock Hotel just across the street from the station. Jim McKeel, another Heartland member that has spent a lot of time with the railroad had left the morning before they arrived. The next day the two rode aboard the first class Parlor Car on the trip to Antonito. A very good meal was served to the passengers at Osier, the midway point of the trip. Upon their arrival at Antonito they took the bus back to Chama. From Chama the duo went to Alamosa where they spent the night. The next morning found them aboard the La Vita Pass train, in the observation car, naturally. This trip proved to be interesting, aside from the scenery a sun kink developed beneath the car they were riding moving the ties and rails along with the coach twelve-fifteen inches toward the edge of of the ballast. This happened on a curve with a very sharp drop off of a couple of hundred feet. The remains of several freight cars were still in the process of being removed after the last derailment. After several hours waiting for the track crew who assessed the problem, the train was walked slowly through the problem area. This made the stay in La Vita longer than anticipated when it was decided that the track could not be repaired in time to get us back to Alamosa until long after dark. A bus eventually arrived to pick us up for the ride back. It turned out that the bus was not an air conditioned scenic cruiser but a very old, underpowered, forty five passenger, yellow, school bus without any air conditioning other than putting the windows down. After several stanzas of 99 bottles of beer on the wall and the wheels of the bus go round and round, the group arrived back in Alamosa around 7:15pm. The pair then headed east toward home. It was planned to maybe spend the night in Dodge or Garden City. Dave who was driving was still wide awake and it was decided to keep on going until we got tired. We arrived home around 7:00am the next morning and the trip is now filed away in our memories. I highly recommend this trip to anyone who likes a lot of beautiful scenery and old time mountain railroading.
